This is an unsanctioned KICKBALL tournament Entry Form (Limit first eight teams for each division – total 16 teams)

The [Roster and Injury Liability Waiver](#) must be signed by each player and turned into the Tournament director at least fifteen minutes prior to your team's first game or mailed with invitation form (Team registration booth will be provided.) Failure to comply will mean elimination of your team from the tournament.

Each team is allowed 20 players Maximum, **children of appropriate age will be allowed on citywide Div. B teams only.**

Area churches, businesses and neighborhoods are encouraged to make it an annual event to get to know your neighbors and friends and for fun bragging rights throughout the year.

Umpires are AREA PROFESSIONALS form the CAA (Chan Athletic Assoc.) and their decisions are final

Entry fee is **\$100.00** for **Div. A** league teams and **\$25.00** for **Div. B** citywide teams and must be received by June 11th, 2010. Entries after this date until June 21<sup>st</sup> will be assessed an Extra \$10.00 late entry fee.  
(Bracket forms, tournament info will be sent by **(emailed only)** by June 22<sup>nd</sup>.)
